**UNIVERSITI TEKNOLOGI MARA** (hereinafter referred to as "**UiTM**"), an institution of higher learning established under the Universiti Teknologi MARA Act 1976, for the purpose of this MoU represented by UiTM Cawangan Johor (hereinafter referred to as "by UiTM Cawangan Johor") whose address is at the UiTM Cawangan Johor, Kampus Segamat, Jalan Universiti Off KM. 12 Jalan Muar, 85000 Segamat, Johor Darul Takzim and shall include its lawful representatives and permitted assigns;

**AND**

**Universitas Islam Negeri Alauddin Makassar** (hereinafter referred to as "**UIN Alauddin**"), for the purpose of this MoU represented by UIN ALAUDDIN MAKASSAR (hereinafter referred to as "UIN Alauddin") whose address is Jalan H. M. Yasin Limpo No. 36 Romang Polong Gowa South Sulawesi, Indonesia and shall include its lawful representatives and permitted assigns;

(The parties are hereinafter referred to singularly as "the Party" and collectively as "the Parties")

**WHEREAS**

- A. Universiti Teknologi MARA (UiTM) is an established University with a track record of educational excellence and research and with a dynamic programme of collaborative arrangements with many national and international counterparts, and UiTM Cawangan Johor is a renowned branch of the university.
- B. Universitas Islam Negeri Alauddin Makassar (UIN Alauddin), established in 1965, is a state Islamic university located in Romang Polong Gowa, South Sulawesi. Under the purview of the Ministry of Religious Affairs and Ministry of Education and Culture of Republic of Indonesia, UIN Alauddin

is a large coeducational Indonesian higher education institution with an enrollment of 27,062 students. UIN Alauddin has also grown rapidly to become a leading university in South Sulawesi and Indonesia.

- C. The Parties are desirous of entering this Memorandum of Understanding to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

## **NOW THIS MoU WITNESSES AS FOLLOWS:**

### **ARTICLE 1**

#### **OBJECTIVE**

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations and national policies from time to time in force in each party's country, shall endeavour to strengthen, promote and develop academic, cultural, research and industrial co-operation between the Parties on the basis of equality and mutual benefit.

### **ARTICLE 2**

#### **AREAS OF COOPERATION & COLLABORATION**

- 2.1 Both Parties agree to encourage the following activities, in particular, to promote academic and industrial cooperation in the following areas:
- a) institutional exchanges between branch and staff from each partner institution;
  - b) acceptance of undergraduate and graduate students of each partner institution for periods of study and/or research;
  - c) organisation of symposia, conferences, short courses and meetings on research issues;
  - d) exchange of information pertaining to developments in teaching, student development and research institutions;
  - e) mutually promote information and activities of partner organization within the MoU on their respective websites; and
  - f) cooperation in any other areas as agreed to by the Parties from time to time.



- 2.2 For the purpose of implementing the co-operation in respect of any areas stated in paragraph 2.1 the Parties shall enter into legally binding agreements subject to terms and conditions as mutually agreed upon by the parties including clauses on "confidentiality", "suspension", "protection of intellectual property rights" and "settlement of disputes".

### **ARTICLE 3**

#### **FINANCIAL ARRANGEMENTS**

- 3.1 This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.
- 3.2 Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding.

### **ARTICLE 4**

#### **EFFECT OF MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create, and is not intended to constitute or create, obligations under domestic or international law and shall not give rise to any legal process and shall not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

## **ARTICLE 5**

### **NO AGENCY**

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organisation of any kind between the Parties or so to constitute either party as the agent of the other.

## **ARTICLE 6**

### **ENTRY INTO EFFECT AND DURATION**

- 6.1 This Memorandum of Understanding shall become effective as of the date of signatures of both parties, or if the dates vary, then the date of the later signature. .
- 6.2 This Memorandum of Understanding shall remain in effect for a period of FIVE (5) years.
- 6.3 This Memorandum of Understanding may be extended for such further period as may be agreed in writing by both parties.
- 6.4 If the Memorandum of Understanding is not renewed by mutual consent, the Memorandum of Understanding shall conclude at the end of the specified period, or after activities in progress have concluded.

## **ARTICLE 7**

### **REVISION, VARIATION AND AMENDMENT**

- 7.1 Either party may request in writing a revision, variation or amendment of this Memorandum of Understanding.
- 7.2 Any such revision, variation or amendment agreed to by the Parties shall be in writing and shall form part of this Memorandum of Understanding.

- 7.3 Such revision, variation or amendment shall come into force on such date as may be determined by the Parties.
- 7.4 Any revision, variation or amendment shall not prejudice the implementation of any project, activity or co-operation arising from or based on this Memorandum of Understanding before or up to the date of such revision, variation or amendment.

## **ARTICLE 8**

### **TERMINATION**

This Memorandum of Understanding may be terminated by either party with a minimum of THIRTY (30) days written notice. Activities in progress at the time of termination of this Memorandum of Understanding shall be permitted to conclude as planned unless otherwise agreed.

## **ARTICLE 9**

### **NOTICES**

Any communication under this Memorandum of Understanding shall be in writing in the English language and delivered by registered mail to the address or sent to the electronic mail address or facsimile number of Universiti Teknologi MARA or the Universitas Islam Negeri Alauddin Makassar as the case may be, shown below or to such other address or electronic, mail address or facsimile number as either Party may have notified the other Party and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or facsimile number which is duly acknowledged:

**SETTLEMENT OF DISPUTES**







### BRIEF OF PERSONAL BACKGROUND

After completing a Diploma in Quantity Surveying 1995 from Institute Technology MARA (ITM) and Bachelor Degree in Quantity Surveying from University Technology Malaysia (UTM) in 1998, I have developed a refined set of personal, academic and professional goals. Throughout my graduate studies in Quantity Surveying, I further developed my existing interest in the construction field and education at the same time.
